PRESENTATION OF THE 2023-2024 AUDITED FINANCIALS

Vernon Lawrence introduced Richard Larson, CPA from Novogradic & Associates LLC who presented our 2023-2024 audit.

Mr. Larson advised the Board that the Authority was given an unmodified opinion on their financial statements, which is the highest level of assurance that an auditor can give. He also advised that every New Jersey government is required to have an audit of their government auditing standards which consists of the three categories below:

- 1) Internal controls No deficiencies were identified in the authority's internal controls.
- 2) Compliance with New Jersey laws and federal laws No issues of non-compliance were found.
- 3) Capital Fund Program opinion given was that the Authority complied in all material respects with the type of compliance requirements for the Capital Fund Program.

Mr. Larson explained that the strength of the Authority is measured by their liquidity, current assets less current liability. Currently the Authority has approximately 15 months of operating reserves; HUD says that if the Authority has 4 to 6 months of operating reserves, we are doing well.

Mr. Larson thanked the Board and said that if anyone had questions to not hesitate to contact his office.
